TERMS & CONDITIONS

1. Submission of your registration form does not guarantee your place on a course. Your registration will be confirmed as soon as possible. Please do not make travel arrangements until your place has been confirmed.
2. Payment must be made in full before joining a course. Any delegate who has not paid will be refused entry.
3. Cancellations:
